CONDITIONS: a) The Adopt-A-Park participant/group shall develop and follow a regular schedule of maintenance of the property as agreed upon by the City Fresno and report any park hazards to City staff. b) The Adopt-A-Park contact person shall report all hours volunteered to the Adopt-A-Park Coordinator. c) Each individual participant must complete and sign the City of Fresno's Volunteer Service Application and the Waiver and Indemnity Agreement for Volunteer Service, prior to participating in the Adopt-A-Park Program. d) The City of Fresno may photograph or videotape the events or activity in which the participant is participating for the purpose of promoting the City of Fresno and its services/programs, with the following understanding, "that no compensation of any kind will be paid to the participant".
 ACCESS: Volunteers are allowed access to City property for the purpose of carrying out the terms of this agreement.
The City of Fresno reserves the right to terminate this agreement at any time.

Contractual Agreement

This agreement is entered into by Vocation Plus Connections, Inc. a California Corporation, and *Habitat for Humanity (Almy Playground)* the 10th day of October 2015.

Vocation Plus Connections, Inc.'s Responsibilities:

- 1. Vocation Plus Connections, Inc. will provide worker's compensation coverage, liability coverage, pay all required taxes, and maintain required payroll information on all participants.
- All Vocation Plus Connections, Inc. participants will abide by the established rules and policies of property, employees, and customers with respect and care.
- 3. Vocation Plus Connections, Inc. will be responsible for the following ground maintenance:
 - Mow and edge lawn
 - Sweep walking path
 - Clean and sanitize playground equipment
 - Clean and sanitize swing set
 - Clean and dust park exterior fence
 - Weed surrounding garden area
 - Clean and dust play structures
 - Empty garbage containers and reline
 - Sweep front entrance and walk way
 - Clean and sanitize drinking fountains
- 4. Vocation Plus Connections, Inc. will perform duties every Wednesday with the flat rate of \$220.00 per month and will bill Almy Playground monthly.

Habitat for Humanity (Almy Playground) Responsibilities

- 1. Provide work and assignments to Vocation Plus Connections, Inc. employee(s).
- 2. Pay invoices within 10 days of receipt.

It is further understood that a "HOLD HARMLESS" policy is in effect which places no liability responsibilities with Habitat for Humanity (Almy Playground) with regards to employee work-related injuries. Either party may cancel this contract verbally or in writing at any time.
