To Whom It May Concern:

I am writing to support Tiffany Potter's nomination of Reva Guimont for the 2016 Achievement Award from the City of Fresno Disability Advisory Commission. Without question Ms. Guimont is deserving of this award and exemplifies, both personally and professionally, advocacy for and with individuals with disabilities and their families.

I have known Ms. Guimont since 2009, when I was faculty at Fresno State University. I contacted Ms. Guimont soon after I arrived in Fresno because of her position and work at Exceptional Parents Unlimited. I was faculty in the special education department at Fresno State, and in my position wanted to collaborate with EPU to support pre/early-service teachers in thinking differently about their work with students with disabilities and their families. From the time we met and throughout my three years at Fresno State, Ms. Guimont and I collaborated in my courses, as well as in a number of efforts related to the larger disability community in Fresno. In my class on collaborating with students with disabilities and their families, specifically, Ms. Guimont shared both her professional role at EPU and the role of advocacy in the lives of these students, and also very openly and poignantly shared her experiences as the parent of an adult woman who had lived within the special education system. She spoke about how her daughter was assumed to be incompetent in most special education settings, and also how learning about person-centeredness supported her own transformation, as a parent, and allowed her to support her daughter in creating the life of her choosing and situating her daughter's voice as primary.

During these three years, Ms. Guimont also completed the Citizen-Centered Leadership Community of Practice at Cornell University's Employment and Disability Institute. This CoP is directed by renowned leaders in the practice and philosophy of person-centeredness at Cornell University. As a colleague and a friend, Ms. Guimont and I often engaged in extended conversations about the CoP, our own thinking related to disability and citizenship practices, and how too many disability-related agencies and systems did not utilize a person-centered approach. I was thrilled when she started a local CoP dedicated to thinking through and talking about citizenship and person-centeredness and invited me, along with a group of dynamic individuals to come together on a monthly basis.

Since 2012 I have lived in Colorado and returned to San Francisco, for faculty positions. Throughout this time I have continued to participate in monthly CoP meetings, facilitated by Ms. Guimont, and witnessed and participated in the growth of the CoP and thinking of the individuals participating within it, due to her work, dedication, and the model which she provides for us all. Ms. Guimont is an exceptional model for many of us working within disability systems, agencies, and with individuals with disability and their families. Her own personal journey, how candidly she shares what she views as mistakes she has made, her pursuit of learning, and how she has brought transformative knowledge into Fresno and the Central Valley have changed current opportunities and experiences for disabled individuals, and more importantly have the ability to influence the futures of many more.

Again, without a doubt, Reva Guimont is more than deserving of this award. I am writing to you in support of the nomination of Reva Guimont to be this year's recipient of the Fresno City Disability Advisory Committee's Individual Award for 2016.

I have had the honor and privilege of being a friend of Reva's for almost 20 years and for 17 of those years I have worked with Reva at The EPU Children's Center. During those years Reva has been a tireless advocate for all children and adults in the Central Valley that live with special needs. Reva was originally thrown into the world of disability by her daughter Natasha whom she adopted as an infant. Natasha had the unfortunate experience of receiving a brain trauma as an infant. Reva has worked since that time day and night to provide the most inclusive life possible in order for Natasha to reach her full potential as an adult.

Reva and her husband have since become vendorized with Central Valley Regional Center to begin a program for Natasha that is 100% inclusive and 100% based on the principals of Person Centered Planning through a Circle of Support.
