# Sustainable Groundwater Management Act (SGMA)

- Adopted in 2014
- Gives local public agencies ability to form Groundwater Sustainability Agencies (GSAs) to comply with SGMA
  - Local public agencies mean those with water supply, water management, or land use responsibilities within the groundwater basin – Water Code §10721(n)
- Counties are backstop to local agencies
- State will intervene if locals and counties fail

### **SGMA** Timeline

- GSAs must be formed by June 30, 2017 in medium- and high-priority basins.
- GSAs must submit Groundwater Sustainability Plan (GSP) by January 31, 2020 in critically over drafted basins.
- City of Fresno resides within the Kings Sub-Basin (Sub-Basin Number 5-22.08) of the San Joaquin Valley Basin (Basin Number 5-22).
- The Kings Sub-Basin is a high-priority basin.
- GSAs must provide annual progress reports and achieve measurable objectives in 5-year milestones.
- Basins must achieve <u>sustainability</u> by January 31, 2040

# What is <u>Sustainable</u> Groundwater Management?

"Sustainability Goal" means a groundwater basin operating within its sustainable yield.






"<u>Sustainable Yield</u>" means the maximum water used over a period of time without causing "undesirable results"

#### What are Undesirable Results?

- Sustainability: Manage groundwater to prevent undesirable results (significant & unreasonable):
  - Chronic Lowering of groundwater levels
  - Reduction of groundwater storage
  - Seawater intrusion
  - Degraded water quality/contaminant plume migration
  - Land subsidence
  - Depletions of interconnected surface water

#### Kings Groundwater Subbasin Memorandum of Understanding

- Approved May 18, 2015
- Approximately 1,000 square miles
- 2 Counties
- Multiple Cities
- Multiple Irrigation and Water Districts
- Wide variability in surface water availability
- Too complex for just
  1 GSA → 5 or 6
  GSAs

# Approach to Develop the NKGSA Governance

- Agency- and stakeholder-led committee
- Committee members include staff of MOU agencies and:
  - Kings River Conservation District
  - Disadvantaged Community Advocates
    - Community Water Center
    - Self-Help Enterprises
  - California State University, Fresno
  - Independent Groundwater Extractors (ag and large business)
- Neutral, third-party facilitation via DWR SGMA Facilitation Support Grant Program

#### **SGMA** Facilitation Support

- NKGSA Stakeholder Assessment
  - One-on-one, small group interviews and selfassessment
  - Comments/findings aggregated without attribution
- Key Findings:
  - Broad agreement to utilize a Joint Powers Agreement (JPA)
  - JPA board comprised of elected officials preferred
  - Provide voting membership path for PUC and Interested Parties

#### JPA Development

- Original draft compiled by a "committee" using text from:
  - Sustainable Groundwater Management Act of 2014
  - Kings Basin Water Authority Joint Powers Agreement
  - Other groundwater management focused JPA's
- JPA Agreement 2-phase refinement:
  - 4 half day committee workshops to revise/agree on elements of JPA
  - 2 half day legal counsel workshops to review JPA for consistency w/ Joint Exercise of Powers Act, SGMA, and agency policies.

#### JPA Powers Reserved

- Committee agreement to retain all powers of 2014 SGSA Act, including:
  - Develop, adopt and implement a Groundwater Sustainability Plan
  - Conduct investigations
  - Monitor and regulate groundwater extractions
  - Assessing fees
  - Coordinating with adjacent GSAs within Kings Sub-Basin
  - Reporting to State
  - Secure new water resources
- JPA does not need to use all powers

#### **Board Members**

- Signatories to JPA pursuant to Joint Exercise of Powers Act
- JPA provides opportunities for entities not covered by §10721(n) to participate as a Board Director via a separate agreement:
  - PUC Regulated water companies may participate as a "Contracting Agency" through a "Participation Agreement"
  - "Interested Parties" may participate through a Memorandum of Understanding

#### **Contracting Entity and MOU Parties:**

- Bakman Water Company
- California State University, Fresno

### **NKGSA** Committees

- Several committees anticipated to support development of GSP and involve the public, stakeholders and other interested parties
- Topic-specific and place-based committees anticipated:
  - Rules and Budget Committee
  - Groundwater Modeling Committee
  - GSP Advisory Committee
  - Public/Interested Party Outreach Committee
  - Interbasin Coordination Committee

# **Voting Thresholds**

- Unanimous vote of Directors for critical issues GSP, Amendments to JPA, Fees
- Affirmative vote of 5 Directors for important issues Debts, Obligations, Policies, Enforcement, Litigation, Budget allocations, Removal of a Member
- Simple Majority for remaining issues

# Funding

- Member contributions until GSP is adopted
- Considered 15 cost sharing alternatives
- Member contributions based on amount of groundwater that member pumps and member's seat on Board of Directors
- Budget projection through January 2020 \$1.9 million
- JPA Board of Directors to determine on-going funding requirements after GSP is adopted



# Sustainable Groundwater Planning Grant Program

- Funds to develop and implement sustainable groundwater planning and projects
- Total Prop. 1 budget: \$100 million
- Early 2017 target for statewide Planning Grant Solicitation
- Draft Guidelines not available yet
- Anticipated 50% local cost share, with likely reduction for regions with DAC and SDAC needs
- Highly competitive process anticipated
- Potential for \$500k-1M to offset GSP development costs
