The wastewater management group conducted an inspection of the downtown sewers and identified sewers in need of rehabilitation and replacement. Through investigation using CCTV, portions of the sewer pipes were found to have structural deficiencies, some were found to be past the design useful life and other pipes are undersized per the City Standard design requirement. DPU recommends removing and replacing 386 feet of 8" sewer, installing 1441 linear feet of CIPP liner, rehabilitating 6 access structures, and abandoning of 385 feet of sewer pipe.
