A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO. CALIFORNIA. **AMENDING** THE **FRESNO** GENERAL PLAN AND THE WOODWARD PARK COMMUNITY PLAN (PLAN AMENDMENT APPLICATION NO. A-16-005)

WHEREAS, on December 18, 2014, by Resolution No. 2014-226, the City Council adopted the Fresno General Plan which correspondingly adopted the Woodward Park Community Plan and, by Resolution No. 2014-225, certified Master Environmental Impact Report SCH No. 2012111015 ("MEIR") which evaluated the potentially significant adverse environmental impacts of urban development within the City of Fresno's designated urban boundary line and sphere of influence;

WHEREAS, Nick Yovino Jr. of California Land Consulting has filed an application to amend the Fresno General Plan and the Woodward Park Community Plan to change the planned land use designation for the subject property from Medium Low Density Residential planned land use to the Medium High Density Residential;

WHEREAS, the environmental assessment conducted for the proposed plan amendment resulted in the filing of a Mitigated Negative Declaration on June 3, 2016;

WHEREAS, on July 20, 2016, the Fresno City Planning Commission held a public hearing to consider Plan Amendment Application No. A-16-005 and the associated Mitigated Negative Declaration prepared for Environmental Assessment No. No. A-16-005/R-16-006/D-16-031;

WHEREAS, the Fresno City Planning Commission took action, as evidenced in Planning Commission Resolution No. 13385, to recommend approval of Plan Amendment Application No. No. A-16-005 which proposes to amend the Fresno General Plan and the Woodward Park Community Plan to change the planned land use designation for the subject property from Medium Low Density Residential planned land use to the Medium High Density Residential; and,

WHEREAS, on August 18, 2016, the Fresno City Council held a public hearing to consider Plan Amendment Application No. A-16-005 and received both oral testimony and written information presented at the hearing regarding Plan Amendment Application No. A-16-005.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno, based upon the testimony and information presented at the hearing and upon review and consideration of the environmental documentation provided, as follows:

1. The Council finds in accordance with its own independent judgment that with all applicable project specific mitigation measures imposed, there is no substantial evidence in the record that Plan Amendment Application A-16-005 may have additional significant effects on the environment that were not identified in the Fresno General Plan Master Environmental Impact Report SCH No. 2012111015 ("MEIR"); and, that all applicable mitigation measures of the MEIR have been applied to the project, together with project specific mitigation measures necessary to assure that the project will not cause significant adverse cumulative impacts, growth inducing impacts, and irreversible significant effects beyond those identified by the MEIR as provided by CEQA Section 15178(a). Therefore, it has been determined based upon the evidence in the record that the project will not have a significant impact on the environment and that the filing of a

mitigated negative declaration is appropriate in accordance with the provisions of CEQA Section 21157.5(a)(2) and CEQA Guidelines Section 15178(b)(1) and (2). Accordingly, the Council adopts the Mitigated Negative Declaration prepared for Environmental Assessment No. A-16-005/R-16-006/D-16-031 dated June 3, 2016.


- 2. The Council finds the adoption of the proposed plan amendment as recommended by the Planning Commission is in the best interest of the City of Fresno.

The Council of the City of Fresno hereby adopts Plan Amendment Application No. A-16-005 amending the Fresno General Plan and Woodward Park Community Plan planned land use designation for the subject property from Medium Low Density Residential planned land use to the Medium High Density Residential, as depicted by Exhibit "A" attached hereto and incorporated herein by reference.
