#### Dear Madam:

We are writing to object to the proposed Environmental Assessment No. A-16-005/R-16-006/D-16-031 and the Plan Amendment Application No. A-16-005 and the Rezone Application No. R-16-006 and the Development Permit Application No. D-16-031 which are to be considered at your Fresno City Council meeting on August 18, 2016.

We feel that the high density plan for 34 living units will create a problem of air pollution due to engine exhausts in our adjacent neighborhood of single family houses. We can expect approximately 68 cars or trucks and several motorcycles in the small two and a quarter acre plot where the development is planned.

The noise produced by that many vehicles will also pose a significant annoyance for the homes bordering the property

In addition, light disturbance from headlights at night will be a major disturbance for the homes bordering the property.

There is already an abundance of high-end apartments in this area, with plenty of vacancies, and located closer to convenient public transportation.

This property could better be utilized for seven to ten lots for single family homes, which would match the surrounding neighborhood and minimize the nuisance factors.
