The League of Women Voters has become aware of a request from Council Member Baines that the hearing on the Southwest Fresno Specific Plan be divided into a public hearing on November 17, at which time public testimony will be taken, and a second hearing on December 1, at which time the final City Council vote will be taken without public comment.

The League has observed occasions in the past when the Council has received modifications from interested parties prior to second hearings. The modifications were not made available to the public in time for meaningful participation. Furthermore, the Council went on to discuss and adopt those modifications with no opportunity for public comment. Such procedures should be cause for concern by every Council member as they are violations of the Brown Act.

A violation of the Brown Act occurs when the public is denied the right of access to information concerning the conduct of the business of the public; therefore, the meetings of public bodies and the writings of public officials and agencies are not open to public scrutiny and public participation.

As Council President, please see that the public has access to all information to be considered by the Council. In addition, please protect the public's right to comment on all elements of the plan at the final hearing by moving the public testimony to the Council meeting of December 1, 2016. Further, please ensure all proposed modification(s) to the Draft Preferred Alternative as submitted to planning staff and Council are made available to the public in a timely fashion.
