SUMMARY

The City of Fresno is a federal entitlement community that receives an annual allocation of HOME Investment Partnerships (HOME) Program funds from the U.S. Department of Housing and Urban Development (HUD). As an entitlement community, the City is required to prepare an annual action plan detailing the uses of HOME funds to meet housing goals as outlined in the 2015-2019 Consolidated Plan.

For fiscal year 2016-2017, the City selected the Habitat for Humanity (Habitat), to receive funding for its B Street and Amador Street Project. On May 12, 2016, at the adoption of 2016-2017 Annual Action Plan, as amended, the project had not yet been identified. Therefore the City proposes, at this time, to substantially amend the FY 2016-2017 Annual Action Plan as follows:

➤ Include Habitat's B Street and Amador Street Project to be funded with HOME CHDO funds in the amount of \$600,000 (\$263,347.43 from FY 2014-2015; \$249,482.10 from FY 2015-2016; and \$87,170.47 from FY 2016-2017)

The B Street and Amador Street project is determined to be a new use of funds and differs from those projects originally approved as part of the 2016-2017 Annual Action Plan. The proposed addition is substantial and requires a 30-day public review and comment period. This Substantial Amendment No. 2017-001, will be made available for public review and comment on July 5, 2016 through August 5, 2015.
