## **COUNCILMEMBER REPORTS AND COMMENTS**

Councilmember Caprioglio stated he was honored to be recognized by the Fresno Chamber of Commerce as one of the most business friendly elected officials in Fresno.

Councilmember Caprioglio reported that California State University, Fresno would be breaking ground on a new performing arts center. He complimented President Castro on the bold steps he takes to move the University forward.

Councilmember Caprioglio also reported that he attended the Crime Stoppers dinner on January 25, 2017. The well attended dinner honored the many sponsors of the very important Crime Stoppers program. Councilmember Caprioglio thanked Manager Estabrooke and Parking Controller Taylor in DARM for going "above and beyond" with their work in District Four. He also thanked Public Works Director Mozier, Public Works Manager Russell and the "street team" for taking care of city streets during the recent downpour. He said his office received many calls for services and then received many calls thanking the city for the prompt service.

Councilmember Soria asked City Manager Rudd about the potential sale of city owned property. City Manager Rudd explained the previous and current administration put together a plan to look into the possible sale of under-utilized city owned property. He noted that all options were being explored, including lease re-negotiations. Councilmember Soria asked that the process be transparent and requested a master list of properties be available to the public on the Fresno City website.

Councilmember Soria announced that her next "morning coffee meeting" with the public would be at Cup of Joy in the Fresno High area on January 31, 2017 at 7:30 A.M.. She encouraged people to visit her to discuss their concerns and ways to improve the city and the district.

Councilmember Soria stated she would stand with the immigrant community even though the administration was not in favor of the city becoming a "sanctuary city." She said the immigrant community was a great contributor to the local economy and she would help make sure there were no local policies that would jeapordize immigrant safety. Councilmember Soria felt building a boarder wall was an irresonsible waste of tax payer money and said the funds would be better spent on pot holes, repaving streets and maintaining parks. She reminded the audience that the agricultural industry relied heavily on immigrant populations and felt there should be concern over the draconian immigration policies being implemented by the President Trump. Councilmember Soria indicated that she spoke with Police Chief Dyer and discovered it was city policy not to focus police efforts on enforcing immigration laws. She said we should advocate for immigration reform and noted people were organizing an event at City Hall on January 27, 2017 to express concerns on the issue.

Councilmember Bredefeld asked City Manager Rudd to include the asking prices on the list of properties owned by the City and to include the properties where leases may be re-negotiated.

Councilmeber Bredefeld stated that he supported the administration's stance that Fresno should not become a "sanctuary city." He also clarified that he was in support of immigration as long as it was legal immigration.
