Councilmember Caprioglio thanked Oasis Adult Daycare for inviting him to say a few words at its open house on Wednesday, February 8, 2017. He commented on the facilities passion for taking care of people. He explained that Oasis was an adult daycare that specialized in Alzheimer's and dementia care and said it offered therapeutic activities for seniors. The company allows caregivers to take much needed breaks. He encouraged people taking care of loved ones to look into Oasis programs.

Councilmember Caprioglio also congratulated the Airports Department for a

record breaking number of passengers traveling through Fresno Yosemite International Airport last year.
