Commissioner Catalano asked if projects listed in the Active Transportation Plan are budgeted in the Capital Improvement Plan. Public Works Director Scott Mozier confirmed they are.

Commissioner Catalano asked if an update could be given regarding projects in the Jane Adams area. Scott Mozier indicated that projects are done not by timeline, but when funding is available.

Commissioner Catalano asked Ashley Werner about a comment letter not received.

Commissioner Holt cautioned prioritizing only projects in low-income areas.
