The minutes of March 2, 2017 were not discussed and will be considered during the March 16, 2017 City Council meeting.

COUNCILMEMBER REPORTS AND COMMENTS

Councilmember Caprioglio reported on the March 4, 2017 grand opening of the sports fields at Granite Park. He said the location was once blighted but had been transformed into a thriving place for kids and adults.

Councilmember Caprioglio noted a baseball tournament took place that day

with 39 teams participating. Everyone had a great time during that "historical day in District Four." He thanked his council colleagues, the Mayor, the City Manager, the City Attorney and his team, Terance Frazier and T.J. Cox for their efforts.

Councilmember Caprioglio reported on his attendance at the United Khmer Cultural Preservation cultural and entertainment event at the 509 Club. He thanked Fresno Police Detective Danny Kim for working with the community to put on the event. Councilmember Caprioglio noted that Detective Kim had an excellent voice and was "Mr. Entertainment" the entire night.

Councilmember Caprioglio commented on his attendance at the California Restaurant Association Awards on March 4, 2017. He congratulated Jim Pardini for receiving the Lifetime Achievement Award and the Best Italian Restaurant. Councilmember Caprioglio noted it was a family affair that started with Jim Pardini's father and has continued with Jim's son.

Councilmember Caprioglio thanked Mayor Brand and his council colleagues for participating in Kids Day at the "Celebrity Corner" at Blackstone and Shaw on March 7, 2017. He stated the goal was to reach \$625,000 and the current tally was at \$400,000. Councilmember Caprioglio felt the Kids Day fundraiser would reach its goal in support of Valley Children's Hospital which he said performed miracles every day.

Councilmember Bredefeld thanked City Manager Rudd, Public Works Director Mozier, Development and Resources Management Director Clark, Public Utilities Director Esqueda, Deputy Police Chief Farmer, Police Captain Bridges and Police Sergeant Landon for their support at his first District Six meeting. He referred to them as "tremendous public servants" for attending the meeting from 6:00 P.M. to 7:30 P.M after a long day at work.

Councilmember Chavez announced he attended the ribbon cutting ceremony at the new Steak and Shake restaurant in his district. He recalled that the food was so good he had been to the restaurant three times that week and noted there was always a line. He recommended everyone try the food and support the local business which was planning on opening five restaurants locally.

President Olivier announced he had authored an editorial in the Fresno Bee on March 5, 2017 concerning the sad state of senior citizens in the

community. He was prompted to write the piece after the Fresno Unified School District closed a "community-type center" with classes at Manchester Center. President Olivier received many calls after the closing and realized seniors had no place to go in Fresno. He noted many comperable cities had at least one, and even as many as six, senior centers. He said it should be a source of shame that Fresno has no senior centers. He felt it was time for a discussion and that budget prioritiztion should be a tool used to establish a senior center. President Olivier announced he would propose, in a few weeks or months, a task force with members from the Administration, Council, and stake holders such as seniors and members from the Fresno Madera Area Agency on Aging.

Councilmember Bredefeld and Councilmember Caprioglio commented on President Olivier's editorial and the lack of senior centers in Fresno.
