The current low bidder Madco Electric, Inc. is being by passed because they have been determined to be non-responsive due to not filing the required Disadvantage Business Enterprise (DBE/GFE) with lack of the good faith effort documentation that is necessary as required by the project funding authority. American Paving Co. therefore becomes the next lowest responsive, responsible bidder. Their bid is higher than the Engineer's Estimate due to the abundance of work in the project's electrical requested discipline. Current projects have Electrical Contractors tied up with downtown street improvements for the Fulton Mall, the Bus Rapid Transit (BRT), High Speed Rail (HSR) and other similar projects. With the amount of work currently being requested the City is experiencing an increase in electrical contractor work.
