RE: Council Agenda Item ID17-492, 2015-2023 Housing Element Amendment

Mayor Brand and Councilmembers:

We are writing on behalf of our clients, Familias Addams por un Mejor Futuro, with respect to the draft amendment to the City's 2015-2023 Housing Element before you today. As you know, Familias Addams, along with many other residents and community stakeholders, have advocated for years for the City to fully engage the public in its development and implementation of housing and community development policies, identify and maintain adequate sites to meet the City's need for affordable housing, adopt strong and clearly worded programs to address the housing needs of all Fresno residents, and take action to affirmatively further fair housing by directing investment to under-resourced neighborhoods and by expanding housing choice in high opportunity areas consistent with its obligations under state and federal housing laws.

The proposed Housing Element Amendment now includes some necessary analysis and programs to achieve these ends. Among these, the Amendment includes commitments by the City to: conduct multi-lingual outreach to obtain resident input on housing policy development and implementation; consistently maintain sufficient adequate sites with appropriate sizes and zoning to meet the housing needs of all Fresno residents; accommodate the City's unmet lower-income housing need from the prior housing element planning period with adequate sites available for multi-family development by right; facilitate the preservation of affordable and high quality mobile home park units; monitor and adopt policies to prevent resident and business displacement resulting from Downtown revitalization; invest in infrastructure and service provision in the neighborhoods with the greatest need; and zone land, coordinate with the Housing Authority and affordable housing developers, and direct funding to create housing opportunities in high opportunity neighborhoods.

Familias Addams will continue to work to ensure that the City implements each of the Amended Housing Element's programs in a timely, transparent, and comprehensive manner in partnership with residents and community stakeholders throughout the City. The law requires no less, and the City's fulfillment of its duty to its constituents to advance access to safe and affordable housing opportunities for all residents depends on it.
