AN ORDINANCE OF THE CITY OF FRESNO, CALIFORNIA,
UPDATING THE OFFICIAL ZONING MAP AS DESCRIBED BY
SECTION 15-108 OF THE FRESNO MUNICIPAL CODE, AND
PURSUANT TO THE PROCEDURES SET FORTH IN ARTICLE 58,
CHAPTER 15 OF THE FRESNO MUNICIPAL CODE

WHEREAS, Rezone Application No. R-16-020 has been filed by Jeffrey Roberts of Granville Homes, on behalf of AFREI, INC., with the City of Fresno to rezone property as depicted in the attached Exhibit "A"; and,

WHEREAS, pursuant to the provisions of Article 58, Chapter 15, of the Fresno Municipal Code, the Planning Commission of the City of Fresno held a public hearing on the 19th day of April 2017, to consider Rezone Application No. R-16-020 and related Environmental Assessment No. R-16-020/C-16-062/T-6160 dated March 3, 2017, during which the Commission considered the environmental assessment and rezone application, and recommended to the Council of the City of Fresno approval, as evidenced in Planning Commission Resolution No. 13448, of the subject environmental assessment and rezone application to amend the City's Zoning Ordinance on real property described herein below from the RS-5 (*Residential Single Family, Medium Density*) zone district to RS-5/PD (*Residential Single Family, Medium Density/Planned Development*) zone district; and,

WHEREAS, the Council of the City of Fresno, on the 25th day of May 2017, received the recommendation of the Planning Commission.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF FRESNO DOES ORDAIN AS FOLLOWS:

SECTION 1. Based upon the testimony and information presented at the hearing and upon review and consideration of the environmental documentation provided, the adoption of the proposed rezoning is in the best interest of the City of Fresno. The Council finds in accordance with its own independent judgment, that there is no substantial evidence in the record that Rezone Application No. R-16-020 may have additional significant effects on the environment that were not identified in the Fresno General Plan Master Environmental Impact Report SCH No. 2012111015 ("MEIR") and that all applicable mitigation measures of the MEIR have been applied to the project to assure that the project will not cause significant adverse cumulative impacts. In addition, pursuant to Public Resources Code, Section 21157.6(b)(1), Council finds that no substantial changes have occurred with respect to the circumstances under which the MEIR was certified; and, that no new information, which was not known and could not have been known at the time that the MEIR was certified as complete, has become available. Accordingly, the Council adopts the Finding of Conformity prepared for Environmental Assessment No. R-16-020/C-16-062/T-6160 dated March 3, 2017.

SECTION 2. The Council finds the requested RS-5/PD (*Residential Single Family, Medium Density/Planned Development*) zone district is consistent with the existing Medium Density Residential planned land use designation of the Fresno General Plan and Bullard Community Plan.

SECTION 3. The Council finds that the zone district of the real property described herein below, located in the City of Fresno, is reclassified from the RS-5 (*Residential Single*

Family, Medium Density) zone district to RS-5/PD (*Residential Single Family, Medium Density/Planned Development*) zone district, as depicted in the attached Exhibit "A".

SECTION 4. This ordinance shall become effective and in full force and effect at 12:01 a.m. on the thirty-first day after its passage.
