# **Newsrack Ordinance: Why Do We Need a Policy?**

- It is in the public interest to establish regulations that balance the right to distribute information through newsracks with the right of persons to reasonably access and use Public Property.
- The public health, safety, welfare, and convenience require that interference with vehicle, bicycle, mobility devices or pedestrian traffic be avoided.
- Newsracks placed on public property, absent some reasonable regulation, may unreasonably interfere with the use of such property, and may present hazards to persons or property.



### **Newsrack Ordinance: Goals**

- Create a Special Newsrack Area when special circumstances require special design, placement and other standards.
- Establish a Visual Standard for Newsracks placed within Special Newsrack Areas.
- Establish a sense of order out of chaos and provide a friendly environment for those who come to the area.



# Existing Newsrack Facilities within the Public Right-of-Way










# **Standards in Special Districts**




#### NOTES:

- 1. REQUIREMENTS FOR NEWSRACKS IN SPECIAL DISTRICTS CAN BE FOUND IN CHAPTER 13 ARTICLE 7 OF THE FRESNO MUNICIPAL CODE.
- 2. NEWSRACK DIMENSIONS SHALL BE APPROVED BY CITY ENGINEER.
- 3. NEWSRACK WINDOWS SHALL OPEN TOWARD CENTER OF SIDEWALK.
- 4. CORNERS SHALL HAVE A MINIMUM RADIUS OF 1/8" PER PROWAG 11B-307.3.1
- 5. MODULAR NEWSRACK SHALL BE MODEL 100 BY MECHANISM EXCHANGE & REPAIR INC., OR APPROVED EQUAL.
- 6. NEWSRACK SHALL BE BLACK UNLESS OTHERWISE APPROVED BY CITY ENGINEER.

### **Elements of a New Policy**

- Public Safety
- Address Visual Blight
- Ensure Clear Line of Sight
- Address Liability and Risk
- Standardize Placement and Location
- **Develop Uniform Appearance**
- Securely Affix to Ensure Stability

## **Permitting and Maintenance**

- Any newsracks being anchored to the sidewalk within the public right-of-way must obtain a Street Work Permit prior to installation.
- All Newsracks placed within the public right-of-way in a Special Newsrack Area must comply with the design criteria.
- Enforcement: Any person who violates any provision shall be guilty of an infraction.
- Abandonment: If no applicable permit has been obtained.
- Indemnification automatically provided to the City upon placement within public right-of-way.

### **Newsrack Ordinance: Next Steps**



May 25, 2017: First reading (intro)

June 8, 2017: Second reading (adoption)

**Following Council Adoption:** Public Works to implement the permitting process, starting 30 days from adoption.

**Full compliance:** 60 days from effective date.
