A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, ADOPTING SUBSTANTIAL AMENDMENT NO. 2017-02 TO THE FISCAL YEAR (FY) 2016-2017 ANNUAL ACTION PLAN; AUTHORIZING SUBMISSION TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) FOR REPROGRAMMING \$1,054,879 OF COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM FUNDS; AND AUTHORIZING THE CITY MANAGER TO SIGN ALL IMPLEMENTING DOCUMENTS REQUIRED BY HUD APPROVED AS TO FORM BY THE CITY ATTORNEY.

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) requires jurisdictions that receive federal entitlement program funds to prepare an Annual Action Plan, which identifies the projects to be funded with Community Development Block Grant (CDBG) Program funds; and

WHEREAS, on May 12, 2016, the Council of the City of Fresno adopted Resolution 2016-67 approving the City of Fresno (City) FY 2016-2017 Annual Action Plan; and

WHEREAS, the City has identified \$1,054,879 for reprogramming within the FY 2016-2017 Annual Action Plan; and

WHEREAS, the City has prepared Substantial Amendment 2017-02 to the FY 2016-2017 Annual Action Plan, consistent with the five year Consolidated Plan, which the City Council adopted on June 23, 2015; and

WHEREAS, the thirty-day public review and comment period concluded on June 12, 2017, with no public comments received; and
