A RESOLUTION OF THE COUNCIL OF THE CITY OF
FRESNO, CALIFORNIA, AUTHORIZING THE
ACCEPTANCE OF A FUNDING OPPORTUNITY FROM
KaBOOM! TO FUND A COMMUNITY PLAYGROUND
BUILD PROJECT

WHEREAS, City of Fresno (City) staff has submitted an application to KaBOOM! Incorporated, (KaBOOM!) a national non-profit, for a funding opportunity to install a new playground in Granny's Park, 2024 E. Pontiac Way, Fresno, California (Project); and

WHEREAS, if selected as a funding recipient, KaBOOM! will provide all playground equipment, provided that the City contributes \$8,500 to KaBOOM!, which will apply the funds directly to the purchase of playground equipment for the Project; and

WHEREAS, Council District 7 has agreed to provide the \$8,500 contribution on behalf of the City for the Project; and

WHEREAS, the total cost for the Project is estimated be a minimum of \$75,000; and

WHEREAS, KaBOOM! also requires the City to enter into a Community Partner Agreement if selected as a recipient of the funding opportunity in order to ensure that the funds are used for their designated purpose.

3. If the City receives the grant, the City Council authorizes the City Manager to execute the Community Partner Agreement governing the use of the funds and completion of the Project.

4. If the City receives the grant, the City Council authorizes the City Manager to accept the play structure from KaBOOM!
