The off-ramp has a left-turn lane, right-turn lane and a dual left-right turn lane. Because of growing traffic congestion, this lane configuration creates delays. The project will add a lane to create dual turn lanes in each direction. The off-ramp project will relieve congestion and reduce delays. The project includes an asphalt pavement grind and overlay, striping and pavement markings, replacement of traffic loop detectors, minor concrete improvements and modifications of curb ramps to meet ADA compliance.


