The one sealed bid proposal received and publically opened on June 6, 2017 was from Bush Engineering Inc. who was the sole responsive and responsible bidder submitting a price of \$188,800.00 to perform the work.

BACKGROUND OF PROJECT (To be completed by Evaluating Department/Division. Explain need for project/equipment):

The project involves the repair of the High Density Polyethylene (HDPE) lined recycled water storage basin. The facility uses only one pond to store water and does not have a backup pond for redundancy. This places a greater need on the pond for system operation. The soil below the HDPE liner has slipped, causing duress to the integrity of the HDPE liner and the pond. The project will involve removal of the HDPE liner where the damage has occurred, reconditioning of the soil below the liner, liner replacement, re-seaming and leak testing. The work will aid in maintaining the pond in an operable condition.

\$50,000.00 in funds are available for this project in the Wastewater Division – NFWRF Pond Rehabilitation Account No. TC000153, Fund 40501/Org 414501. Approval of an AAR resolution is necessary to appropriate an additional \$171,300.00 in funds from the FY17 budget into the FY18 capital budget.
