On behalf of Fresno County Farm Bureau (FCFB), I write in support of the "Unhealthy and Hazardous Camping Control Act".

In recent months, our FCFB office, located north of Roeding Park near Caltrans and the California Highway Patrol, has experienced a significant increase of campers on our property and on the adjacent city property. Many individuals have taken up residence on the sidewalk and streets. We have had our property defaced and damaged by these individuals who refuse to leave the area. While we understand this ordinance will not be a solve-all, it will be a tool to help Fresno Police Department combat this issue.

We are requesting that the Fresno City Council and Mayor Lee Brand to support this measure and implement it as immediately as possible instead of the proposed 31-day period. The safety of our employees and members coming to and from our office has continued become more worrisome, as these campers and their animals remain nearby all hours of the day.

FCFB thanks you for spearheading the Unhealthy and Hazardous Camping Control Act, and we look forward to working with you in the future on additional solutions to this issue.
