The Department of Public Utilities Wastewater management division currently operates 2 potable water wells at the RWRF. These wells are critical for potable water for plant staff, fire protection, environmental lab operations, and emergency wash down locations. The RWRF has been expanded substantially over past decade to a point where the failure of one of these wells causes a reduction in available fire protection flows below the Fire Department requirements. The drilling and subsequent construction of a new potable well will ultimately


