

FOURTH AMENDMENT TO CONSULTANT SERVICES AGREEMENT
BETWEEN THE CITY OF FRESNO
AND
RISICO CLAIMS MANAGEMENT, DBA AMERICAN ALL RISK LOSS
ADMINISTRATORS (AARLA)

This FOURTH AMENDMENT TO CONSULTANT SERVICES AGREEMENT (Amendment) dated as of the 1st day of October 2017, by and between City of Fresno (CITY), and Risico Claims Management, formerly known as American All Risk Loss Administrators (AARLA), a California corporation (CONSULTANT), is to amend the CONSULTANT SERVICES AGREEMENT (AGREEMENT) between parties.

RECITALS

WHEREAS, CITY and CONSULTANT entered into an AGREEMENT dated March 1, 2013, and as amended on August 31, 2015, for professional claims administration services for administering CITY's workers' compensation claims; and

WHEREAS, CITY and CONSULTANT desire to amend SCOPE OF SERVICES in the AGREEMENT to add 1 Claims Supervisor and 2 Claims examiners as well as limit the amount of bill review fees when performing reviews of hospital bills.

AGREEMENT

NOW, THEREFORE, in consideration of the above recitals, which recitals are contractual in nature, the mutual promises herein conditioned, and for other good and valuable consideration hereby acknowledge, the Parties agree that the AGREEMENT is hereby amended as follows:

1. Exhibit A, SCOPE OF SERVICES, SCHEDULE OF FEES AND EXPENSES, is amended to reflect a dedicated claims unit comprised of (2) Supervisors, (10) Adjusters, and (2) Claims Assistants. The Consultant will receive as compensation \$274,076 annually, payable in equal monthly installments of the extended contract in addition to the previously agreed to annual fee of \$828,000 for Claims Administration Services.
2. Exhibit A, SCOPE OF SERVICES, MEDICAL BILL REVIEW, UTILIZATION, AND RELATED COST CONTAINMENT SERVICES, PARAGRAPH 2 is amended to add the following:
 - a. Consult with the City in the selection of the PPO network used for Bill Review proposes in order to achieve the most optimal results.
 - b. Establish a revenue cap of \$10,000 per bill for all hospital bills paid by the Consultant in behalf of the City.
