RESOLUTION OF THE COUNCIL OF THE CITY OF
FRESNO, CALIFORNIA, APPROVING THE APPLICATION
FOR GRANT FUNDS FROM THE UNITED STATES
DEPARTMENT OF TRANSPORTATION'S
INFRASTRUCTURE FOR REBUILDING AMERICA
PROGRAM AND AUTHORIZING THE EXECUTION OF
DOCUMENTS BY THE PUBLIC WORKS DIRECTOR OR
DESIGNEE

WHEREAS, the Infrastructure for Rebuilding America Program (INFRA) provides grant funds to eligible local agencies for the purpose of constructing infrastructure projects which support national and regional economic vitality goals; and

WHEREAS, the United States Department of Transportation administers INFRA and has requested applications from eligible agencies; and

WHEREAS, an applicant's governing body must certify by resolution, approval of the application, program participation, timeline for construction readiness and the availability of the required minimum matching funds; and

WHEREAS, the City of Fresno desires to apply for INFRA funding and enter into an agreement with the Department of Transportation for construction of the project.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. Approves the application for grant funding from the Infrastructure for Rebuilding America Program for the project and participation therein consistent with constitutional and local law requirements and this resolution.

4. Appoints and authorizes the Director of Public Works or designee, and each of them as agents for the City of Fresno, to execute and submit all grant application related documents, subject to prior approval as to form by the City Attorney's Office.
