A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, TO APPROVE A SOLE SOURCE PURCHASE AGREEMENT WITH INFOR FOR THE PURCHASE OF ENTERPRISE ASSET MANAGEMENT

SOFTWARE SEAT LICENSING

WHEREAS, the Department of Public Utilities (Department) owns and operates a

Computerized Maintenance Management System (CMMS) known as Enterprise Asset

Management (EAM) by Infor, Inc. (Infor), for the operation and maintenance of vertical

assets at the Wastewater Management Division (WMD); and

WHEREAS, the Department is seeking to purchase additional software licenses

to expand EAM's capabilities for use by the Water Division; and

WHEREAS, despite its best efforts, the Department has determined that Infor is

the only vendor supplying EAM as it is the software developer and no third party

resellers exist for the software; and

WHEREAS, old versions of the EAM are no longer supported and clients are

required to upgrade to receive support and for functionality; and

WHEREAS, the City's prior agreement for the EAM is with Infor's predecessor

and outdated such that its format does not meet the requirements of Infor or the City,

therefore a current order form, product license purchase, and support agreement must

be approved; and

WHEREAS, the Department seeks to leverage its current investment in EAM by

purchasing additional licenses, allowing its Water and Wastewater Divisions to utilize

one CMMS to manage vertical assets and warehouse inventory; and
