A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, IN SUPPORT OF THE ASIAN BUSINESS INSTITUTE RESOURCE CENTER SUSTAINABLE GROUNDWATER PLANNING GRANT PROGRAM APPLICATION

WHEREAS, The Sustainable Groundwater Management Act (SGMA) was signed into law in 2014, establishing a framework for sustainable, local groundwater management for the purpose of halting groundwater basin overdraft; and

WHEREAS, SGMA requires Groundwater Sustainability Plans (GSPs) to be developed for medium- and high-priority groundwater basins identified within the Department of Water Resources Bulletin 118 report; and

WHEREAS, Fresno County overlies five groundwater sub-basins; Kings, Madera, Delta-Mendota, Westside, and Pleasant Valley, all of which except Pleasant Valley are designated as high-priority basins and subject to a condition of critical overdraft, and that these basins must have their GSPs in place by 2020 and achieved their sustainability goals by 2040; and

WHEREAS, The Water Quality, Supply, and Infrastructure Improvement Act of 2014 (Proposition 1) authorized the issuance of \$7.12 billion in general obligation bonds through the State of California to finance water quality, supply, and infrastructure improvement program. \$100 million has been made available in the Sustainable Groundwater Planning (SGWP) Grant Program through Proposition 1 for competitive grants projects that develop and implement groundwater plans and projects in accordance with groundwater planning requirements; and
