A RESOLUTION OF THE COUNCIL OF THE CITY OF

WHEREAS, on December 7, 2017, the Council of the City of Fresno (Council) adopted Council Resolution No. 2017 - _____ calling a special mailed-ballot election on changing the types of Services and the rate and method of apportionment the special tax and authorizing the levy of a new Maximum Special Tax for Annexation No. 74 of Community Facilities District No. 11 (CFD No. 11); and

WHEREAS, the Council has received, reviewed and hereby accepts the City of Fresno City Clerk's (City Clerk) Canvass and Statement of Election Results, dated _____, 2017, a copy of which is attached as Exhibit A;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Council finds and declares that: (a) the ballot measure on changing the types of Services and the rate and method of apportionment the special tax and authorizing the levy of a new Maximum Special Tax for Annexation No. 74, has been submitted to the qualified electors within the area of Annexation No. 74, pursuant to Council Resolution No. 2017 - _____, and (b) the ballot measure has been passed and approved by more than two-thirds of the votes cast, in accordance with City of Fresno

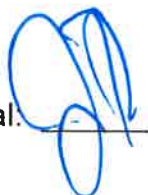

Special Tax Financing Law, Chapter 8, Division 1, Article 3, of the Fresno municipal Code (City Law).

2. The Council declares Annexation No. 74 to be fully formed and the property within Annexation No. 74, to be subject to the levy of the new Maximum Special Taxes and the special tax lien described in Resolution No. 2017 -_____, and authorizing the levy of a new Maximum Special Tax therein, and Council Resolution No. 97-126, approving local goals and policies for Community Facilities Districts, as described in the amended Community Facilities District Report dated as of November 10, 2017, on file with the City Clerk.

3. The Council directs the City Clerk or designee to record a notice of special tax lien in the Office of the County Recorder, pursuant to City Law, no later than 15 days after this resolution is adopted.
