This letter is in regards to the above mentioned Public Notice #3448755; Notice of Public Hearing dated December 27, 2017. There are several issues that H.E.A.T. would like the Council Members to address prior to taking any action on this agenda item.

- 1. HUD requires that a 30 day notice be given, per page 7 of HUD guidelines, in order for the public to provide input prior to any action to be taken. The date of this public notice is dated December 27, 2017 and the Council will hear and consider this agenda item on January 11, 2018, which is less than 30 days. Bigby Villa Apartments and Westgate Gardens Apartments provide low income and Section 8 housing to those that qualify.
- 2. How can the City Council hear and consider information concerning a proposed plan of financing providing for the issuance by the California Public Finance Authority of multifamily housing revenue bonds in one or more series issued from time to time. It also states including bonds issued to refund such revenue bonds in one or more series from time to time. What exactly does this mean and how many years could these revenue bonds be issued and reissued?
- 3. Why is the City of Fresno involved when the housing projects in question are to be acquired and rehabilitated by Reliant Valley, LP, (the borrower) a private developer who will ultimately own the housing projects?

4. What, if any, liabilities will the City of Fresno be responsible for if the developer defaults on these projects?

H.E.A.T. is requesting a written response to the above mentioned concerns regardless of the action taken by the City Council.
