Caustic soda prices rose at a robust pace in May 2017. Since then demand of caustic soda has increased, while production has decreased, causing a dramatic increase of pricing. The Water Division has also added another facility (Southeast Surface Water Treatment Facility) to be delivered to, which is another factor that contributes to the increase. (16)
