WHEREAS, on June 20, 2013, the City of Fresno (City) entered into an

approximately \$4.6 million for the High Speed Rail Impacted Business Support Services

Program (Program) for an initial two year period beginning June 30, 2013, through June

30, 2015, with an additional two year extension through June 30, 2017 (CHSRA

Agreement); and

WHEREAS, on June 30, 2013, the CITY entered into a separate business

support services consulting contract with the Economic Development Corporation

Serving Fresno County (EDC) of approximately \$1.2 million funded through the CHSRA

Agreement; and

WHEREAS, the outcomes of the Program through the efforts made by both City

and EDC staff have been successful in providing high quality customer service to the

property owners and businesses impacted either directly or indirectly by the High Speed

Rail project and ensuring these impacted businesses remain viable within our

community; and

WHEREAS, due to circumstances outside the control of the City, a second

extension request for the CHSRA Agreement was not executed in a timely fashion and

as a result, the CHSRA will only consider a new agreement and budget effective March 1, 2018, through December 31, 2019; and

WHEREAS, CHSRA has agreed to cover the costs already incurred for the Program's services from July 1, 2017, through December 31, 2017, through a portion of the remaining funds under the expired contract; and

WHEREAS, Program services have stopped during January and February of 2018 and no further relocation services can be provided by the City or EDC until a new agreement is in place with CHSRA; and

WHEREAS, the revised budget of approximately 1.6 million to be funded by the CHSRA under the new contract agreement will continue the successful efforts of the High Speed Rail Impacted Business Support Services Program.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno, as follows:

1. The City Manager is hereby authorized to enter into a new contract agreement with CHSRA for continued funding of the High Speed Rail Impacted Business Support Services Program.
