There are international, national, state, county and city companies that have requested your approval for contracts within our neighborhoods. Contracts that appear to benefit us with employment, clean air, law protection of workers and solidarity with the poor and most vulnerable in our society, but there is no clear commitment to our concerns.

The reality is that these companies have not yet consulted us, Grupo Francisco of O.L.M.C., prior to their business request for approval for city, county, state. Therefore we, the unprotected neighbors' community in the southwest of Fresno request to be invited to their table of conversation to discuss what benefits would these companies bring to our neighbors in the whole southwest area of Fresno.
