A RESOLUTION OF THE COUNCIL OF THE CITY OF
FRESNO ESTABLISHING THE WEST AREA SPECIFIC
PLAN STEERING COMMITTEE

WHEREAS, the Council desires to prepare a specific planning document for future Council consideration for the West Area in order to provide for orderly and compatible development, and in order to set forth a long term planning vision and guidance for development in the proposed plan area; and

WHEREAS, involvement of community stakeholders in creating a specific planning document provides significant benefits to the City and to the West Area community; and

WHEREAS, creation of a steering committee encourages involvement and participation of community stakeholders and the broader community in preparing the specific plan.

NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED by the Council of the City of Fresno the following:

1. The West Area Specific Plan Steering Committee is hereby established.
2. The purpose of the West Area Specific Plan Steering Committee is to encourage and facilitate community involvement in preparation of the West Area Specific Plan and to report its findings, recommendations, and work product to the community, Planning Commission and Council.
3. The West Area Specific Plan Steering Committee shall continue to exist until the mission of the body is completed. The West Area Specific Plan

Steering Committee shall automatically terminate upon adoption of the West Area Specific Plan unless otherwise terminated and disassembled by Council resolution.

4. The membership shall consist of:
 - a. 11 total members in the following proportions:
 - i. District 1: 5 members;
 - ii. District 2: 3 members;
 - iii. District 3: 3 members.
 - b. The members shall be appointed in the following manner by the following:
 - i. District 1 members shall be appointed by the duly elected Councilmember for District 1;
 - ii. District 2 members shall be appointed by the duly elected Councilmember for District 2;
 - iii. District 3 Councilmembers shall be appointed by the duly elected Councilmember for District 3.
 - c. Qualifications for the members shall include residency, employment, or property ownership within the Plan Area.
5. The term of office shall be at the pleasure of the appointing member.
6. Compensation shall be zero.
7. The Staff Representative shall be Rodney L. Horton of the Long Range Planning Division of the Development and Resource Management Department.
