There is an increase of \$30/AF since 2013 to produce water from this well due to plugging perforations. A well video dated 3/14/2012 revealed the plugging and the need to clean this well. The original pump of 1800 GPM was downsized to 1200 GPM to avoid excessive drawdown. Once cleaned, this well will increase in production and cost less to pump.

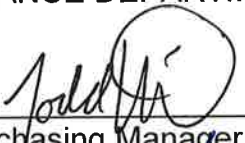


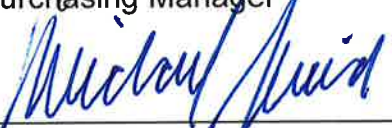
