A RESOLUTION OF THE COUNCIL OF THE CITY OF
FRESNO, CALIFORNIA, TO DEDICATE A PORTION OF
CITY-OWNED PROPERTY FOR WATER MAIN
EASEMENT PURPOSES, LOCATED ON THE INYO
STREET ALIGNMENT, WEST OF "H" STREET

WHEREAS, the City of Fresno (the "City") owns the Lots from the map of the Official Map of the Town of Fresno, recorded in Book 1 of Plats at Pages 1 & 2, Fresno County Records, located on the Inyo Street alignment, West of "H" street; and

WHEREAS, the City acquired APN: 467-040-20, 22 & 23, of the Official Map of the Town of Fresno, recorded in Book 1 of Plats at Pages 1 & 2, Fresno County Records, by that Final Order of Condemnation, as Document No. 2003-0166439, Official Records of Fresno County; and

WHEREAS, the proposed dedication, as described in Exhibit "A" and shown on Exhibit "B", which are attached hereto and incorporated in this Resolution is needed to accommodate the requirement for construction of a recycled water distribution system for Department of Public Utilities.

WHEREAS, the Traffic and Engineering Division has determined that it is necessary to dedicate an easement for Water Main purposes; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. That certain portion of City-owned property described in attached Exhibit "A" and shown on attached Exhibit "B" is hereby dedicated as an easement for Water Main purposes.

Nothing contained in this resolution shall be deemed or interpreted by any party to cause any interest created in the public pursuant to this resolution to ripen into any title, interest or right of the public against or adverse to the rights of the City of Fresno nor shall this resolution limit, restrict or modify the exemption of public property to title by prescription as defined within California Civil Code Section 1007.

3. The City Clerk of the City of Fresno shall certify to the passage of this resolution and attest thereto under the seal of the City of Fresno.

4. The City Engineer shall cause a City deed number to be assigned to this resolution and shall cause this resolution to be recorded in the Office of the Recorder of the County of Fresno, California. The original resolution shall be returned to the City Clerk after recordation and a certified copy thereof shall be filed in the Public Works deed file.
