A RESOLUTION OF THE COUNCIL OF THE CITY OF  
FRESNO, CALIFORNIA, CREATING RESIDENTIAL  
PERMIT PARKING DISTRICT NO. 10

WHEREAS, Article 20 of Chapter 14 of the Fresno Municipal Code (Code) provides for the designation of residential permit parking districts pursuant to procedures set forth therein; and

WHEREAS, residents of 50% of the dwelling units in the area proposed to be included, which area is depicted in EXHIBIT "A", attached hereto and incorporated by reference herein (District), have submitted a verified petition to the Chief Administrative Officer (CAO) ; and

WHEREAS, the Parking Manager of the City of Fresno, acting as the designee of the CAO has undertaken and completed a study and determined that the District satisfies the designation criteria for a residential permit parking district due to the facility known as the Fresno Veteran's Hospital; and

WHEREAS, on June 14, 2018, the Council conducted a duly noticed public hearing in accordance with the Code.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. The Council finds and determines:
  - a. That Fresno Veteran's Hospital is a major complex which attracts visitors, employees, and other commuter vehicles during the period and days established pursuant to Section 3 of this Resolution.

b. The residents of the District desire and need residential permit parking and are willing to bear all or part of the administrative costs in connection therewith, as such costs are defined in Article 20 of Chapter 14 of the Code on the effective date of this resolution.

2. The District depicted in EXHIBIT "A" is hereby designated and adopted as Residential Permit Parking District No. 10.

3. Pursuant to Section 14-2007 of the Code, appropriate signs shall be erected on each block face of such District which prohibit stopping at any time between 7:00 a.m. and 7:00 p.m. all days.

4. The fee for residential parking permits in the District are set by the Master Fee Schedule which is in effect on the date of this resolution, and as amended from time to time. Said fee, on the effective date of this resolution, is for one (1) residential parking permit per dwelling unit, free of charge, within the District as shown on Exhibit "A". Up to three (3) additional permits per dwelling unit may be purchased at the Master Fee Rate effective on the date of this resolution. No additional permits are allowed for visitors or special occasions.

5. Pursuant to Section 14-2107 of the Code, the Parking Manager is directed to cause appropriate signs to be erected on each such block face, indicating prominently thereon the parking time limitation, period of the day and days for its application and exemption of permit parking as established pursuant to the provisions of this Resolution.
