Cannabis Workshop

Resolution of Initiation

- December 14, 2017
- Council directed amendment to zoning code to allow <u>medical</u> cannabis operations, cultivation, manufacture, extraction, testing, distribution, delivery, and dispensaries within the City.

Director Initiation

- March 2018
- Amend zoning code to allow <u>adult use</u> cannabis cultivation, manufacture, extraction, testing, and distribution, but *not* retail sales or delivery.

Cannabis Process

- Cannabis Business License Tax
- Regulatory Ordinance
- Text Amendment to the Zoning Code
- Amend Cultivation Ordinance
- Continue to prohibit Public Consumption
- CEQA requirements

Cannabis Business License Tax

- Special Tax
 - 90% to general fund; 10% to Community Benefit Fund
- Tax Rate
 - Tax cultivation up to \$12 per canopy square foot annually
 - Tax other cannabis businesses up to 10% of gross receipts
- Applies to medicinal and adult-use

Cannabis Business License Tax

Ballot question:

Shall the measure taxing cannabis cultivation up to \$12.00 per canopy square-foot annually and up to 10% of gross receipts for medical dispensaries and all other cannabis businesses; generating up to \$10 million annually; with 90% of revenues to be used for vital unrestricted general revenue purposes such as police, fire, roads and parks and 10% placed in a Community Benefit Fund for allocation by a special citizens commission, until repealed by voters, be adopted?

- Separate Articles for Medicinal and Adult-Use.
 - Council may adopt one or the other, or both.
- Includes operating requirements for each type of cannabis business
 - Security Requirements approved by Fresno PD
- Lays out the procedure and requirements to obtain a Commercial Cannabis Business Permit
 - Business would need to go through the application process through City Manager's Office. Once selected for a Commercial Cannabis Business Permit, would need to apply to DARM for a Cannabis CUP. Once both obtained, operations may begin.
- Permit must be renewed annually

- Cannabis Business Hub
 - Light and Heavy Industrial Districts within 1 mile of Hwy 99 and within 1 mile of Hwy 180 west of Hwy 99; Wastewater Treatment Facility if rezoned; not within 1,000 feet of:
 - Residentially zoned parcel
 - School (pre-K through 12)
 - Daycare Center
 - Youth Center (as defined in the ordinance parks, playgrounds, facility hosting activities for minors)

- Cannabis Hub
 - 4 allowed, plus one more Council defined area
 - All <u>cultivation</u>, <u>distribution</u>, and <u>manufacturing</u>
 must take place inside a Hub
 - Laboratory testing may take place in a Hub, or in a Commercial, Employment, or Downtown District

Retail

- 14 total, with 2 per Council District
 - Option to add 7 more by Council Resolution
- Only 7 allowed in first year; after 9 months, 7 more may begin permit process if PD and CMO can manage
- DTN (Downtown Neighborhood), DTG (Downtown General), CMS (Commercial Main Street), CC (Commercial Community), CR (Commercial Regional), CG (Commercial General), CH (Commercial Highway) and 800 feet from:
 - · A medicinal cannabis retail business
 - School (pre-K through 12)
 - Daycare Center
 - Youth Center (as defined in the ordinance parks, playgrounds, facility hosting activities for minors)
- 9am-9pm hours of operation
- Delivery allowed if part of store-front operation
