A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, AUTHORIZING SUBMISSION OF FUNDING REQUESTS TO THE LOW CARBON TRANSIT OPERATIONS PROGRAM FOR THE SECOND YEAR OF INCREASED FREQUENCY WEEKEND BUS SERVICE AND EXTENDED NIGHT SERVICE, EXECUTION OF GRANT AWARD DOCUMENTS IF AWARDED, AND EXECUTION OF RELATED CERTIFICATIONS & ASSURANCES AND AUTHORIZED AGENT FORMS

WHEREAS, the City of Fresno's Department of Transportation (FAX) is an eligible project sponsor and may receive state funding from the Low Carbon Transit Operations Program (LCTOP) for transit projects; and

WHEREAS, applicable statutes related to state-funded transit projects require a local or regional implementing agency to abide by various regulations; and

WHEREAS, Senate Bill 862 (2014) named California Department of Transportation (Caltrans) as the administrative agency for the LCTOP; and

WHEREAS, Caltrans has developed guidelines for the purpose of administering and distributing LCTOP funds to eligible project sponsors (local agencies); and

WHEREAS, FAX wishes to implement the LCTOP project(s) listed.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

1. FAX is authorized to submit the following project nominations and allocation requests to Caltrans in FY 2017-18 LCTOP funds:

- a. Increased Frequency Weekend Service - \$629,786
- b. Extended Night Service - \$350,000
