

FRESNO CITY PLANNING COMMISSION RESOLUTION NO. 13538

The Fresno City Planning Commission, at its regular meeting on June 20, 2018, adopted the following resolution relating to Street Name Change Application No. SNC-2018-01.

WHEREAS, Alison Tolladay, on behalf of the Community Food Bank, in accordance with Section 15-6204 of the Fresno Municipal Code, filed a request to rename an approximate 600 foot segment of East Hardy Avenue to East Amendola Drive, located near the intersection of South Cedar and East North Avenues; and,

WHEREAS, the Planning Commission conducted a public hearing to review the proposed street name change in accordance with Section 15-6204 of the Fresno Municipal Code and considered the staff report and invited testimony with respect to the proposed request; and,

WHEREAS, during the June 20, 2018, hearing, the Commission received a staff report and related information, environmental document and considered testimony regarding the requested street name change; and,

WHEREAS, in the staff report dated June 20, 2018, staff recommended that the Commission support the applicant's request to change the street name of an approximate 600 foot segment of East Hardy Avenue to East Amendola Drive, located near the intersection of South Cedar and East North Avenues, as allowed pursuant to Section 15-6204 of the Fresno Municipal Code; and,

WHEREAS, the Fresno City Planning Commission heard testimony in support of the Street Name Change, the testimony included information on the life and work of Lou Amendola and how Valley Wide Beverage has become one of Fresno's leading businesses and has been acknowledged by its peers as a leader in sales, customer service and social responsibility as well as providing the Community Food Bank the opportunity to purchase the former Valley Wide Beverage facility at below market value and combined it with a donation of over \$2 million in cash and furnishings; and,

WHEREAS, no one spoke in opposition to the proposed project.

NOW, THEREFORE, BE IT RESOLVED that the Fresno City Planning Commission hereby finds and determines that, in accordance with its own independent judgment, there is no substantial evidence in the record to indicate that Street Name Change Application No. SNC-2018-01 may have a significant effect on the environment and hereby recommends adoption of the Finding of No Possibility of Significant Adverse Effect dated June 8, 2018.

BE IT FURTHER RESOLVED that the Fresno City Planning Commission hereby recommends to the City Council that Street Name Change Application No. SNC-2018-01 be approved, as shown on attached Exhibit A.


