A RESOLUTION OF THE COUNCIL OF THE CITY OF FRESNO, CALIFORNIA, TO APPROVE STREET NAME NO. SNC-2018-01 CHANGE APPLICATION ACCORDANCE WITH ARTICLE 62, CHAPTER 15 OF THE FRESNO MUNICIPAL CODE

WHEREAS, in accordance with Article 62 of Chapter 15 of the Fresno Municipal Code (FMC), Street Name Change Application No. SNC-2018-01 has been filed by Alison Tolladay, on behalf of the Community Food Bank, to rename an approximate 600 foot segment of East Hardy Avenue to East Amendola Drive, located near the intersection of South Cedar and East North Avenues; and

WHEREAS, in accordance with the provisions of the "Street Names & Addressing" Ordinance, Article 62 of Chapter 15 of the FMC, staff reviewed the requested name change to an existing street and recommended that the Fresno City Planning Commission support the request to rename an approximate 600 foot segment of East Hardy Avenue to East Amendola Drive, located near the intersection of South Cedar and East North Avenues; and

WHEREAS, the application is proposed as allowed pursuant to Section 15-6204 of the FMC, which allows street name changes pursuant to City policies and historically, the naming of streets has been allowed for the purpose of honoring or calling attention to persons or places having special prominence and significance to the culture or the history of the city; and

WHEREAS, the Community Food Bank will be relocating to the former Valley Wide Beverage facility, which is three times its current size and fully furnished, because of the generosity of Lou Amendola and his family; and

WHEREAS, the Planning Commission of the City of Fresno held a public hearing on June 20, 2018, to consider Street Name Change Application No. SNC-2018-01 and related Environmental Assessment No. SNC-2018-01, during which the Commission recommended to the Council of the City of Fresno approval of the subject street name change application and environmental assessment as recommended by staff.

WHEREAS, the Fresno City Council held a public hearing to consider Street Name Change Application No. SNC-2018-01 on July 26, 2018.

NOW, THEREFORE, BE IT RESOLVED that the Council, based upon its own independent judgment, determines that there is no possibility that Street Name Change Application No. SNC-2018-01 may have a significant effect on the environment pursuant to CEQA guidelines, Section 15061 (b) (3), and hereby adopts the Finding of No Possibility of Significant Adverse Effect dated June 8, 2018.

BE IT FURTHER RESOLVED that the Fresno City Council hereby approves Street Name Change Application No. SNC-2018-01, changing the name of an approximate 600 foot segment of East Hardy Avenue to East Amendola Drive, located near the intersection of South Cedar and East North Avenues, as depicted on attached Exhibit A.
