More noteworthy is that the division's mechanical staff complement includes nineteen Master Technicians representing the highest level of individual ASE recognition possible; and
WHEREAS,	of these Master Technicians, three are certified as both Master Automotive Technician and Master Medium/Heavy Truck Technician; and
WHEREAS,	maintain the City's diverse 2000 plus unit fleet ranging from patrol cars to refuse trucks to
