2. The public interest and convenience require, and it is hereby ordered, that as contemplated by Resolution of Intention No. 1125-D adopted by the Council on August 30, 2018, the public street right-of-way, pipeline, and utility easement as shown

3. The City further reserves a public utility easement over that portion of the

proposed area to be vacated as shown in Exhibit "B".
