Andrew Benelli from Public Works presented this item to the Committee. He explained that the City has an Agreement with San Joaquin River Conservancy to provide an entitlement before the end of the year so that a road and a parking lot for 50 vehicles will be provided along the Eaton Trail. The access point is at the north end of North Palm Avenue. This access point would allow citizens to hike or jog along the trail and provide kayakers access to the river. The two lane road traveling down the bluff faces requires a variance due the steepness of the bluff. In addition, it will require the removal of 5 sycamore trees. In accordance with the Environmental Assessment that was approved by the Conservancy Board, those 5 trees will be replaced at a 5 to 1 ratio. The 25 new sycamores trees will line parts of the road as well as be planted around the parking lot. The City of Fresno has noted that there is no money to provide for maintenance of this project. Therefore, the project will not be built until there is a commitment by some agency to provide for that maintenance. Assemblyman Joaquin Aramabula introduced a bill to extend the State's maintenance of Friant Dam/Millerton Lake all the way down to Freeway 99, however, it was vetoed by Governor Brown. The Committee expressed concern about the lack of a commitment for maintenance, but on a motion by Scott, and second by Feath, it

was moved to approve the project. Motion carried 4-0 with Hendry's vote via email. Chairman Rodriguez adjourned the meeting there being no further business.

Barnes thanked the Committee for attending this special meeting.
