BACKGROUND OF PROJECT (To be completed by Evaluating Department/Division. Explain need for project/equipment):

The project will replace wooden pole and overhead wiring system with City standard street lights. The proposed undergrounding project will improve aesthetic conditions along Blackstone and Abby, clearing it of the overhead PGE lines and creating consistency throughout, as this type of undergrounding was done in the 1990's on Blackstone north of Shields Avenue. The project will also place additional City standard spaced street lights at location that were missing lighting. Blackstone and Abby is a key corridor in the Fresno General Plan and is home to the newly built Bus Rapid Transit (BRT); these improvements will greatly restore and help revitalize this corridor.
