## DOG LICENSE INFORMATION

**Dog licenses are required** in the **City of Fresno** for all dogs over 4 months of age.

A City of Fresno dog license is valid from the **DATE OF RABIES VACCINATION**, for a period of 12 months (or up to 36 months if purchased in advance, through Rabies expiration date).

### YOU MAY OBTAIN A DOG LICENSE:

- 1) By mail to City of Fresno, P.O. Box 45017, Fresno CA 93718-5017
- 2) In person, at Fresno City Hall, 2600 Fresno St, Rm 2162 (entrance on P St., between Tulare and Fresno Sts).  
*We recommend that you call ahead to verify hours open.*
- 3) In person, at the CCSPCA, 103 S. Hughes Ave, Fresno (559-233-7722, ext. 214)

### TO OBTAIN A DOG LICENSE, MAIL IN (or bring with you):

- 1) This form, completed
- 2) A copy of a current valid Rabies Vaccination certificate (originals will not be returned)
- 3) Fee - make checks payable to City of Fresno Dog License (DO NOT MAIL CASH); see fees and effective dates below.
- 4) A copy of Spay or Neuter certificate, if applicable (originals will not be returned)

### LICENSE FEES (eff. July 1, 2010):

Late penalty if paid after due date:	\$10.00		

*The 3 year discounted rate is only available the year that you present us with a current Rabies Vaccination Certificate good for three years.*

### LICENSE YOUR DOG WITHIN 30 DAYS AFTER:

- Your dog becomes 4 months old
- You acquire your dog (dog is over 4 months old). Dog licenses (tags) are not transferable.
- You and your dog move here from out of town (call 621-6880 for details)
- After 30 days there is a late fee of \$10.00

- If your dog license is lost, you may obtain a replacement tag for 50¢. (DO NOT MAIL COIN or CASH.) Mail check or money order for \$.50, with note requesting replacement tag.
- The metal tag some veterinarians issue with the rabies shot is **not a license**. The certificate you received with that tag is what you submit with the fee to obtain your dog's license from the City of Fresno.
- If you adopt a "new" dog at the SPCA, you will be charged the license fee at the time you adopt your dog. Often you will not be issued a dog license tag until you go back to the SPCA with a valid rabies vaccination certificate & SPCA receipt. Their phone number is (559) 233-7722 ext. 214.
- You may own up to 4 adult dogs and/or cats. Kennels and Commercial establishments may be exempt from limit.
- An adult dog's rabies shot is generally valid for 3 years, while a primary, or "puppy shot" is valid for only one year.

If you move, please call us at (559) 621-6880, fax us at (559) 457-1202 or mail us a note with your name, dog license tag number(s), old and new addresses and telephone numbers so that we can update our records. Please include your account number for quicker processing. Call or write us if your dog is deceased or if you no longer own the dog (licenses are not transferable).
