WHEREAS, the City has prepared Substantial Amendment 2018-01 to the FY 2018-2019 Annual Action Plan, consistent with the five year Consolidated Plan, which the City Council adopted on June 23, 2015; and

WHEREAS, the thirty-day public review and comment period concluded on January 28, 2019, with no public comments received; and

WHEREAS, the City desires to submit Substantial Amendment No. 2018-01 (Exhibit "A") to the FY 2018-2019 Annual Action Plan to HUD to reflect changes made
