WHEREAS, the Position Authorization Resolution sets forth the number of positions authorized by the City during the fiscal year; and

WHEREAS, given the differing needs and priorities of each Council District, Council finds it in their interest to have flexibility and discretion in the staffing needs of their individual Council District offices, within the bounds of their District adopted budget.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Fresno as follows:

 Part II of the Position Authorization Resolution shall hereby be amended as follows:

THAT a change in the total number of permanent full-time positions authorized in a department or office in any section of Part V or permanent part-time and permanent intermittent positions authorized in a department or office in any section of Part VI shall only be accomplished by Resolution of the Council. That the number of persons employed in permanent full-time positions shall not exceed the total number of authorized positions in a department or office in any section of Part V, and that the number of persons employed in

permanent part-time or permanent intermittent positions shall not exceed the total number of authorized positions or their full-time equivalency in a department or office in any section of Part VI; except as noted in Part III (e); and,

[Provided, however, each Councilmember shall direct the Personnel department from time to time as to the number of requested positions in that Council District office, which then shall be reflected in the current Position Authorization Resolution numbers. Staff shall take all necessary actions to amend the Position Authorization Resolution to account for the staffing needs of each Council District.; and]

- 2. Part III (f) of the Position Authorization Resolution shall be amended as follows:
- (f) that any adjustment made pursuant to (a), (b), (c), (d), or (e) above shall only be made within guidelines established by the City Manager [or as directed by this Resolution]; and,

3. This Resolution shall be effective immediately.
