A RESOLUTION OF THE COUNCIL OF THE CITY OF
FRESNO, CALIFORNIA, APPROVING THE INSTALLATION
OF THE FRESNO VETERANS MEMORIAL ON THE
SOUTH LAWN ADJACENT TO THE FLAG POLES IN
FRONT OF CITY HALL.

WHEREAS, we owe a great debt to those from Fresno who have served in
defense of this nation; and

WHEREAS, the City Council deems it necessary and appropriate to erect a
memorial to the citizens of Fresno who have lost their lives fighting for their country; and

WHEREAS, the City desires to erect a memorial at Fresno City Hall to honor the
277 men and women from Fresno who lost their lives in World War I, World War II,
Korea, Vietnam, Afghanistan, and Iraq; and

WHEREAS, the Fresno Veterans Memorial will be a beautiful tribute to all of the
men and women in uniform from the City of Fresno that made the ultimate sacrifice
defending our Country; and

WHEREAS, the freedoms and liberties we enjoy as Americans are the result of
the sacrifice all veterans have made throughout our history; and

WHEREAS, those who have fought, suffered, and died defending our freedoms
enable us to debate and exchange ideas at City Hall so that we can better the lives of
this and future generations.
