AN ORDINANCE OF THE CITY OF FRESNO, CALIFORNIA, ADDING SECTION 14-813 OF THE FRESNO MUNICIPAL CODE, RELATING TO THE SAFE TRANSFER OF OBJECTS TO PEDESTRIANS

THE COUNCIL OF THE CITY OF FRESNO DOES ORDAIN AS FOLLOWS:

SECTION 1. Section 14-813 is added to the Fresno Municipal Code to read:

SECTION 14-813. UNLAWFUL TRANSFER ON VEHICULAR PORTION OF THE RIGHT-OF-WAY.

- (a) A person commits the offense of unlawful transfer on vehicular right-of-way if the person:
 - (1) While a driver or passenger in a vehicle, gives or relinquishes possession or control of, or allows another person in the vehicle to give or relinquish possession or control of any item of property to a pedestrian; or
 - (2) While a pedestrian, accepts, receives or retains possession or control of any item of property from a driver or passenger in a vehicle, or loiters within 200 yards of a signalized intersection for the purpose of violating this section.
 - (b) This subsection applies to transfer from vehicles:
 - (1) Queued at a signalized intersection;

(2) Within 200 yards of a signalized intersection; or

- (3) Stopped anywhere that would be a violation of Chapter 14, Article 10 of this code.
- (d) This subsection does not apply if the vehicle is legally parked. This subsection also does not apply to transfer to persons participating in an activity permitted under Chapter 14, Article 25 of this Code, so long as all terms of the permit are being met.
- (e) The City Attorney may charge any violation of this section as an infraction, punishable upon conviction by a fine not to exceed seventy-five dollars (\$75) for the first offense, one hundred fifty dollars (\$150) for a second offense within six months, and three hundred dollars (\$300) for each subsequent offense within six months.
- (f) The city shall utilize the city's portion of any fine collected under this article for traffic safety improvements.
- (g) This ordinance shall sunset and be of no effect one year following its effective date, unless action is taken by the Council to extend it.

SECTION 2. This ordinance shall become effective and in full force and effect at 12:01 a.m. on the thirty-first day after its final passage.
