South Willow Avenue south of East Jensen Avenue is currently on septic systems. After their relocation, inquiries were made regarding the possibility of providing access to the City of Fresno's sewer system. An initial design was requested for 150 linear feet of 10-inch sewer main to accommodate those relocated businesses. Additional requests were made by parcel owners along South Willow Avenue and the design was increased to approximately 734 linear feet of 10-inch sewer main. The intent of this project is to provide sewer service to approximately nine property owners on South Willow Avenue.
