This Project includes construction of approximately 2.9 mile 16-inch diameter pipeline and will bring recycled water from the RWRF Tertiary Treatment facility located at West Jensen Avenue and South Cornelia Avenue to Madison Elementary School, Nielsen Basin, and future Oasis residential development.
